Article I - Name

The name of this corporation is BOCA MILLWORK SALES, INC.

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose



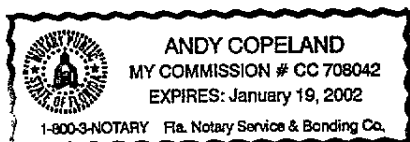
