ARTICLES OF INCORPORATION OF

ARTICLE I-Name

The name of this corporation is M & H Trucking of Lorida, Inc.

ARTICLE II- Principal Office

The address of the principal office is 217 Varner Road, Lorida, Florida 33857.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock
