**CAPITAL STOCK**

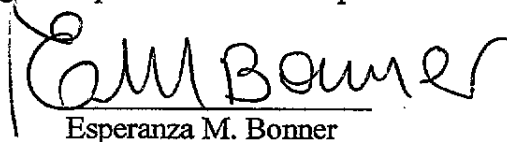
The capital stock of this corporation shall be One Thousand (1,000) shares of common Stock with a par value of One Dollar (\$1.00) per share.

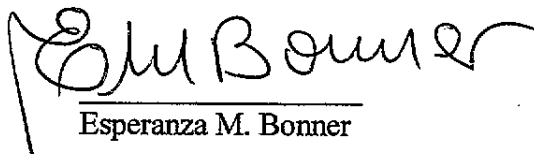
