



PLAN OF MERGER of MULTI-SERVICES STRATEGY, INC.

MULTI-SERVICES STRATEGY, INC., ("MSSI") a Florida corporation and MULTI-SERVICES STRATEGY, INC., ("MULTI-SERVICES") a New Jersey corporation, hereby adopt the following Plan of Merger pursuant to §607.1107, Fla. Stat. (1999);

- 1. The name of each corporation planning to merge is MULTI-SERVICES STRATEGY, INC.,
- 2. The name of the surviving corporation is MULTI-SERVICES STRATEGY, INC., a Florida corporation.
 - 3. The terms and conditions of the Merger are that MULTI-SERVICES shall merge into MSSI and the latter shall be the surviving corporation which shall assume all of the debts, liabilities and duties of MULTI-SERVICES, and likewise shall succeed to all of the assets, property, rights, privileges, power and benefits of said acquired corporation.
- 4. The manner and basis of converting the shares of each corporation is that the shares of MULTI-SERVICES shall be surrendered and for each share of common stock of MSSI, the shareholder of same shall receive one (1) share in MSSI.
 - a. The manner and basis of converting rights to acquire shares of each corporation is that all rights to acquire shares to MULTI-SERVICES shall be void, non-transferable and shall not entitle the holder thereof to the issuance of or any interest in any shares of stock in MULTI-SERVICES; and
 - b. That with regard to MSSI the holder of any such rights to acquire shares of MSSI may convert those interests based upon the terms of each such agreement as set forth herein, however, there are, at this time, no such convertible rights in any interest to or shares of MSSI.

After the merger all shares of MULTI-SERVICES shall be deemed to have been issued in full satisfaction of all rights pertaining to such shares of MSSI and there shall be no further registration of transfers on the records of MULTI-SERVICES of its shares of common stock which were outstanding immediately prior to the effective date of the merger.

5. Pursuant to Section 607.1107 Fla.Stat. (1999), this Merger is permitted by the laws of the State of New Jersey and MULTI-SERVICES has complied with the laws of the State of New Jersey in effecting this merger with the Florida corporation. This Agreement shall be governed by and construed in accordance with the laws of the State of Florida, regardless of the laws that might otherwise govern under applicable principles of conflicts of laws thereof.
