ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is G.W. Construction of Brevard, Inc., 802 Boeing Street NE, Palm Bay, Florida 32907 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
