ARTICLES OF INCORPORATION TROPICANA RESTAURANT, CORP. 1754 West 66th Place Hialeah Florida 33012

ARTICLE I - NAME

The name of this corporation is: TROPICANA RESTAURANT, CORP.

ARTICLE II - DURATION
