The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE ONE

The business of the Corporation shall be managed by a Board of Directors consisting of a minimum of one director and a maximum of six directors.


