The Corporation shall have all of the corporate powers enumerated in the person so entitled by Florida Statutes, vote of the stockholders or otherwise, subject to any limitations prescribed in the effect at the time of such indemnification.

Each shareholder of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares.

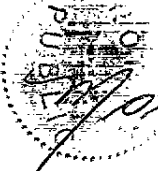
