

ARTICLES OF INCORPORATION

of

RESIDENTIAL SAFETY CONSULTANTS, INC.,
a Florida corporation

Article I
Name

The name of the corporation is RESIDENTIAL SAFETY CONSULTANTS, INC., a Florida corporation.

ARTICLE II
Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing on the 25th day of September, 2001.

ARTICLE III
Purpose

(a) The Corporation may transact business, borrow, lend or otherwise deal or contract to the full extent and subject only to the limitations and provisions of the laws of the State of Florida and the laws of the United States.

This provision shall be in addition to any other rights to which those indemnified may be entitled under any By-Laws, agreements, vote of the shareholders or disinterested directors or otherwise, both as to action in his official capacity and is to continue as to any person who has ceased to be a director or officer, and shall inure to the benefit of the heirs, executors and administrators of such a person.
