ARTICLES OF INCORPORATION

OF

PRINCETON MEDICAL, INC.

ARTICLE I - NAME

The name of this Corporation is PRINCETON MEDICAL, INC.

ARTICLE II - DURATION

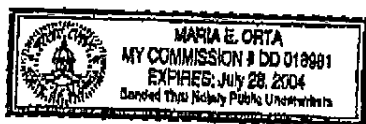


