**ARTICLES OF INCORPORATION
OF

The undersigned does hereby subscribe to, acknowledge and file the following articles of incorporation for the purpose of creating a corporation under the law of the state of Florida.

ARTICLE I - NAME

The name of this corporation shall be JOHNSON CONCRETE, INC.

ARTICLE II - PURPOSE

This corporation may engage in any activity or business permitted under the laws of United States and state of Florida

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 600 shares of \$1.00 per value common stock, which shall be designed as "common shares". All of said stock shall be payable in cash, property (real or personal labor or services lieu there at as just valuation to be fixed by the board of directors

ARTICLE IV - VOTING RIGHT

Except as otherwise provided by the law the entire voting power for the election directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

ARTICLE V - TERM

The corporation shall indemnify any officer or director or any former officer, director to the fullest extent permitted by law either now existing or here after enacted.

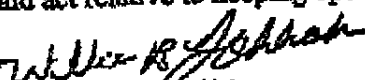
ARTICLE XI
