**ARTICLES OF INCORPORATION
OF
TAYLOR-JACKSON, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation (the "Corporation") shall be:

TAYLOR-JACKSON, INC.

ARTICLE II

This purpose for which this Corporation is organized is to provide administrative services to consumers.

ARTICLE III

This Corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV

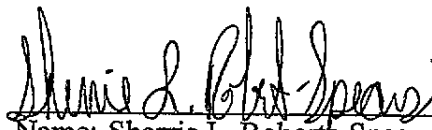

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

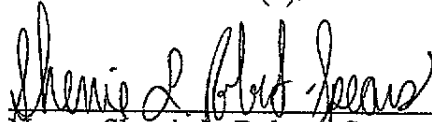
