

In compliance with the requirements of Chapter 621 and 607 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I CORPORATE NAME.

The name of this corporation is Law Office of Scott R. Slanda, P. A.

ARTICLE II PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation are 1850 Tanglewood Drive, Orange City, Florida 32763.

ARTICLE III EXISTENCE & PURPOSE

The existence of the corporation shall begin on October 1, 2001. The Corporation's purpose is to provide legal services.

ARTICLE III CAPITAL STOCK.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred, all of which shall be Common Shares.
