The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of the corporation shall be: **MARIA KEEBLER, P.A.** The initial principal office and mailing address of this corporation is 233 East Bay Street, Blackstone Building Suite # 620, Jacksonville, Florida 32202.

ARTICLE II - NATURE OF BUSINESS

This professional association may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation as a PROFESSIONAL ASSOCIATION. The general purpose of the corporation is to provide legal services.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (100) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share, all of which shall be common stock in the same class. The stockholders shall have no preemptive rights with respect to the capital stock of securities of the corporation.

ARTICLE IV - TERM OF EXISTENCE

The corporation shall exist perpetually.

ARTICLE V - INITIAL REGISTERED AGENT

The initial street address of the initial registered office of this corporation in Florida shall be 233 East Bay Street, Blackstone Building Suite # 620, Jacksonville, Florida 32202, and the name of the initial Registered Agent for the corporation at that address is: MARIA KEEBLER.

ARTICLE VI - PRE-EMPTIVE RIGHTS

Each Shareholder of the common stock of the corporation shall have the right to purchase, subscribe for, or receive a right or rights to purchase or subscribe for, at the price for which it is offered to others, that Shareholder's pro rata portion of the following:

- (A) Any stock of any class that the corporation may issue or sell, whether or not exchangeable for any stock of the corporation of any class or classes, and whether or not of unissued shares authorized by the Articles of Incorporation as originally filed or by any amendment thereof or out of shares of stick of the corporation acquired by it after the issuance thereof, and whether issued for cash or other consideration, or
- (B) Any obligation that the corporation may issue or sell which is convertible into or exchangeable for any stock of the corporation of any class or classes, or to which is attached or pertinent any warrant

or warrants or other instruments conferring on the holder the right to subscribe or purchase from the corporation any shares of its stock of

any class or classes.

This right shall be deemed waived by any Shareholder who does not exercise it and pay for the shares preempted within thirty (30) days after receipt of written notice from the Corporation stating the price, terms and conditions of the issue of shares and inviting the Shareholder to exercise this preemptive right. This right may also be waived by a written waiver signed by the Shareholder.

ARTICLE VII - LIMITATION OF LIABILITY

The Directors and Officers of this Corporation shall be indemnified to the fullest extent permitted by Florida law. Each director, stockholder and officer, in consideration for her services, shall, in the absence of fraud, be indemnified, whether then in office or not, for the reasonable cost and expenses incurred by her in connection with the defense of, or for advice concerning any claim asserted or proceeding brought against her by reason of her being or having been a director, stockholder or officer of the corporation or of any subsidiary of the corporation, whether or not wholly owned, to the maximum extent permitted by law.

ARTICLE VIII - MISCELLANEOUS

In furtherance and not in limitation of the powers conferred by Statute, the following specific provisions are made for the regulation of the business and the conduct of the affairs of the corporation:

- (1) Subject to such restrictions, if any, as are herein expressed and such further restrictions, if any, as may be set forth in the By-Laws, the Board of Directors shall have the general management and control of the business and may exercise all of the powers of the corporation except such as may be by statute, or by the By-Laws as constituted from time to time, expressly conferred upon or reserved to the stockholders.
- (2) Subject always to such By-Laws as may be adopted from time to time by the stockholders, the Board of Directors is expressly authorized to adopt, alter and amend the By-Laws of the corporation, but any By-Law adopted, altered or amended by the Directors may be altered, amended or repealed by the stockholders.
- (3) The corporation shall have such officers as from time to time may be provided in the By-Laws and such officers shall be designated in such manner and shall hold their offices for such terms and shall have such powers and duties as may be prescribed by the By-Laws or as may be determined from time to time by the Board of Directors subject to the By-Laws.

ARTICLE IX - DIRECTORS
