

ARTICLES OF INCORPORATION OF

ARTICLE I.

SECRETARY OF STATE

CORPORATE NAME

The name of this corporation shall be: Royale Jade Trading Corporation

ARTICLE II. NATURE OF CORPORATE BUSINESS
