He suggested a mailing a letter explaining that I did not receive the 2003 Uniform Business Report because the mailing address had the wrong zip code (last year the mailing address was correct and the mailing address has not changed since incorporation) along with a completed Application for Reinstatement and a \$150.00 check payable to the Florida Department of State.

I ask the corporation be reinstated for the original fee of \$150.00 without the \$600.00 reinstatement fee.
