# ARTICLE I NAME

The name of this corporation is BJFC Corporation.

## ARTICLE XIII DIRECTOR QUORUM AND VOTING

A majority of the Directors shall constitute a quorum for a meeting of directors.

If a quorum is present, the affirmative vote of a majority of the Directors present shall be the act of the Board of Directors.

#### ARTICLE XIV AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
