The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, by these articles tomb a contract. natural person competent to contract, and the State of Florida corporation for profit, pursuant to the laws of the State of Florida

FIRST: The name of the corporation is Amat Appraisal, Inc.

SECOND: The period of duration of the corporation is perpetual.

The nature of the business and the objects and purposes to be transacted and carried on are to engage in any business as lawfully permitted under the laws of the State of Florida and the United States of America.

The aggregate number of shares of Capital Stock which the Corporation has authority to issue is 5,000 (five thousand), all of which FOURTH: shall be one class of common stock having a par value of \$1.00 each.
