I

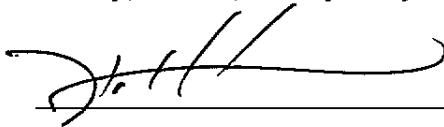

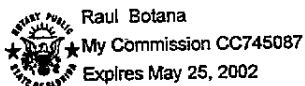
