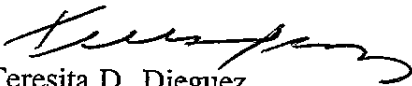

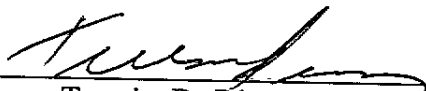
ARTICLE SEVEN - PURPOSE
