The undersigned subscriber to these Articles of Incorporation, competent to contract, hereby associates himself to form a Corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation is: JOY SPECIALTIES INCORPORATED

ARTICLE II

The nature of the business to be conducted and transacted by this Corporation is as follows:

- (1) To engage in the sale of Christian Merchandise as described in Article VI.
- (A) To hire and employ persons with qualifications essential to the performance of the business.
- (B) The said Corporation shall have the power to:  
conduct business in, have one or more offices, buy, sell, hold mortgages, lease, convey or otherwise dispose of real and personal property, Real Estate, franchises, copy rights, trade marks and licenses in the State of Florida and all other states and countries subject to their individual legal requirements.
- (2) To contract debts, borrow money, issue and sell or pledge bonds, debentures, notes, and all other evidence of indebtedness, and execute such mortgages, transfers of Corporated property, or other instruments to secure payment of Corporate indebtedness as required.

- (3) To purchase Corporate assets of any other Corporation and engage in the same character of business.
- (4) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the Capital stock of, or any Bonds, Securities, or other evidences of indebtedness created by any other State or Government, and while owner of such stock to exercise all rights, powers and privileges of ownership including the right to vote such stock.




