### ARTICLE I.

The name of the Corporation is TB & C OF BREVARD, INC., was duly incorporated as of October 3, 2001 by the State of Florida.

## ARTICLE IX. CAPITOL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock, which shall be designated "common shares".

# ARTICLE X. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

All other Articles including the Registered Agent remains unchanged.
