

ARTICLES OF INCORPORATION

OF

RESIDENTIAL HELP CORPORATION



The undersigned, acting as incorporator of RESIDENTIAL HELP CORPORATION under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is RESIDENTIAL HELP CORPORATION (the "Corporation").
