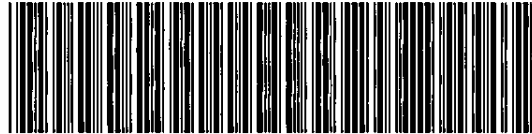

1. That the articles of incorporation of **TERRY E. REHFELDT, P.A.**, are hereby amended by striking Article I in its entirety and substituting the following:

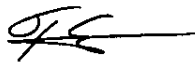
ARTICLE I. NAME
