To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges or franchises, of any other lawful purposes; to issue bonds, promissory notes, bills or exchange, debentures and other obligations and evidences of indebtedness, payable at a specified time or times secured by mortgage or otherwise.

D. To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of the shares of stock of, or any bonds secured or evidence of indebtedness created by any other corporation or corporations and while owning said stock to exercise all rights, powers and privileges of ownership, including the right to vote thereon.

E. To purchase, sell and transfer shares of this own capital stock.

F. To acquire, copy utilize and dispose of patents, copyrights, trademarks and any licenses or other rights or interest therein and thereunder.

G. In general, to carry on any other business in connection with the foregoing and to have and exercise all powers conferred by the laws of the State of the Florida upon corporations formed under the general corporations acts of the State of Florida and any amendments, thereto, and to do any and all things hereinbefore set forth to the same extent as a natural person might or could do.


