ARTICLE ONE

10-15-01
1.01 THE NAME OF THE CORPORATION IS ZOE GREEN, P.A.

ARTICLE TWO
(NATURE OF BUSINESS)

2.01 THE CORPORATION MAY ENGAGE IN ANY ACTIVITY OF BUSINESS PERMITTED UNDER THE LAW OF THE UNITED STATES AND OF THIS STATE. THE DUTIES AND FUNCTIONS OF THE CORPORATION IS TO ACT AS A REAL ESTATE AGENT.
