I am a brand new corporation and this was my first year being required to file a uniform business report. I was unaware of this responsibility until I recently received the attached "2nd request" for my corporate annual report. I never knew I had to do this. I hired a professional to incorporate me and she failed to mention any such requirements to me during the incorporation process. The form went to HER post box because I put that down as my mailing address as I assumed she would forward to me any important business mail. When she confronted me with this 2nd notice, she explained to me that "my original UBR form must have fallen thru the cracks somehow, and she profusely apologized." She said that she usually always discusses the corporate annual report requirements with all clients but we must have gotten side tracked on other topics during the time she helped me get incorporated. She is not an attorney and I cannot therefore hold her responsible for my penalty. She is simply a typist who knows the procedure to get incorporated and she helped me incorporate myself. She is usually very thorough in any other business dealings we have had. I realize that if I incorporate myself, it is my responsibility to make myself aware of this requirement and that ignorance is no excuse of the law; however, I truly do not believe it was my fault this form is now late especially because I never received the form in the first place since it went to her. I realize that I asked for my mail to go to her but she is usually good about giving me my mail and I had other good reasons why I have my mail go to her. Somehow this just got missed. We are all human and all make mistakes. This was an honest mistake that this happened this way. I am therefore pleading with the State for mercy. Since I am a new corporation, I cannot afford a \$400 penalty, especially since it was absolutely not my fault that this happened.

Therefore, PLEASE accept my check for \$150.00 rather than \$550.00 and abate the \$400 penalty. I promise I will do everything in my power to make sure this doesn't happen again. Now that I know I have to file this thing every May 1st, I will be filing it early, much earlier than May 1st!
