
I recently received a packet in the mail that contained a 2002 Uniform Business Report Document for 2002. The information in the packet indicated that I must submit a fee of \$550.00 by September 15, 2002 to ensure the active status of my corporation. Remembering from my initial filing in October of 2001 that the fee was \$150.00, I was concerned with the escalation in the fee for 2002 to \$550.00. I understood the annual filing fee would remain \$150.00.

I contacted The Florida Department of State to inquire about the increased fee and was told by a woman with the name of Esther, that an initial notice was sent to all corporations filed with the State of Florida in January of 2002, indicating that there was a filing deadline of May 1, 2002. I never received a notice in January alerting me to the May deadline. I am confident that I would have responded to such a notice due to my fastidious nature of keeping track of all my tax and corporation paperwork crucial to my new business.

Per Esther's instructions, I am forwarding this letter, the initial \$150.00 filing fee, and the UBR form I recently received in the mail.
