**ARTICLES OF INCORPORATION OF

ARTICLE I-NAME

The name of this corporation is ULTIMATE LENDING RESOURCES, INC.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

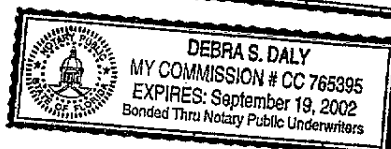
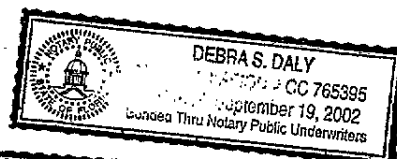


