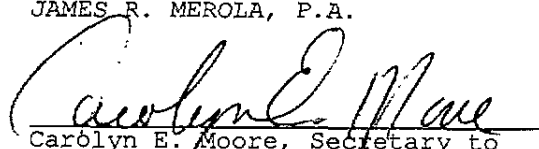

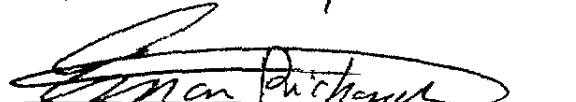
1. The sole Director of the corporation is Eman Marcos Richardson.
