**ARTICLE I - NAME**

The name of this corporation is Ronald J. Trevisani, DMD, P.A. / Orange City

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 301 S. Milwee St., Longwood, Fl. 32750 and may be changed and a principal office established and/or relocated without amending these Articles of Incorporation.

**ARTICLE III - PURPOSE**

This corporation is organized for the purposes of conducting oral surgery.




