ARTICLES OF INCORPORATION

OF

ARTICLE 1. NAME

The name of this corporation shall be AAA ASSET MANACEMENT INC., a Florida Corporation located at 3106 MARSHLANDS COURT, KISSIMMEE, FLORIDA 34743

ARTICLE 2. COMMENCEMENT & DURATION

The commencement of this corporation existence shall be at the time of the filing of these Articles of Incorporation by the Florida Department of State, Divisions of Corporations. This Corporation's duration shall be perpetual.

If this corporation fails or refuses, within such period, to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of such shares without any further restrictions.

On the death of any shareholder, this corporation shall have the right to purchase any shares of the capitol stock of this corporation owned by the shareholder immediately prior to the shareholder's death on the terms set forth above, and this provision shall be binding upon the personal representative of the shareholder.
