#### ARTICLES OF INCORPORATION

OF

#### ARTICLE I - NAME:

The name of this corporation is: P.D. ENTERPRISE OF

N.W. FLORIDA, INC., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:
