ARTICLES OF INCORPORATION OF BILL AND MARGARET CORPORATION

The undersigned, who, if a natural person, is eighteen years of age or older, hereby establishes a corporation pursuant to the Florida Business Corporation Act, as amended, and adopts the following Articles of Incorporation:

Article I. Corporate Name 1-1-02

The name of this corporation is Bill and Margaret Corporation.

Article II. Duration

The corporation shall have an effective date of January 1, 2002, and shall exist perpetually.

Article III. Purpose

The corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the State of Florida and of the United States. Any such purported transfer shall be null and void.
