Your corporation is not dissolved if you miss the May 1 deadline. Corporations are not dissolved until later in the year around September or October. Access codes are random numbers issued by the computer and printed on the UBR packets. If you do not receive that number, you may request a new number in writing and our office will print it and mail you a new number. Unfortunately, that type of request can't be made the day before the deadline. Our system did experience some problems with filings and online payments because of the volume of people trying to file the UBR at the last minute. Thousands of filings went through that day without experiencing problems.

If you attempted to file the UBR online or didn't receive the form in the mail, you may send in a UBR obtained from [www.sunbiz.org](http://www.sunbiz.org) under "Download Filing Forms" and the regular fee of \$150.00 with a note stating that you never received the preprinted form to file. No late fees will be assessed with that type of explanation.
