The undersigned incorporator, for the purpose of forming a corporation under the Florida Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I – NAME

ARTICLE IX – INDEMNIFICATION

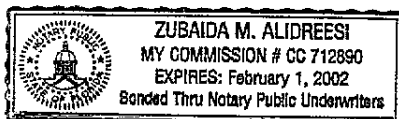
