ARTICLES OF INCORPORATION OF



ARTICLE I. CORPORATE NAME.

GRANGER ELECTRIC, INC.

The name of this corporation is GRANGER ELECTRIC, INC.

ARTICLE II. PRINCIPAL OFFICE.
