To Whom it May Concern,


I recently received a notice that my corporation was being dissolved or revoked because your office did not receive a timely Uniform Business Report. I in fact did send a UBR to the Division of Corporations. I had recently moved from my previous address to my current address and somehow the 2003 UBR was not forwarded to the new address. I realized that the filing date was due, after speaking to someone in your division, he advised to just send in a check for \$150.00 and a letter explaining what had happened, so on May 5, 2003 I sent the check along with a letter explaining the situation. Approximately 4 to 6 weeks later, I get a letter back from your division requesting a current 2003 UBR be resubmitted, then returned to your office, which I completed and mailed. At this point I felt this issue was closed, until being recently advised that the corporation was dissolved.

I recently spoke to a Ms. Casey Taylor about this issue. She did see that a check and letter had been sent in and that my file indicated that your office did receive information concerning my corporation in May of 2003. She recommended that I resubmit another check for \$ 150.00 dollars along with a letter explaining my situation, a waiver should be possible and my corporation be reinstated.

Enclosed is a check for \$150.00 for filing fees on the corporation as noted in the above heading.
