I recently received a notice that my corporation was being dissolved or revoked because your office did not receive a timely Uniform Business Report. I in fact did send a UBR to the Division of Corporations. I had recently moved from my previous address to my current address and somehow the 2003 UBR was not forwarded to the new address. I realized that the filling date was due, after speaking to someone in your division, he advised to just send in a check for \$150.00 and a letter explaining what had happened, so on May 5, 2003 I sent the check along with a letter explaining the situation.
