

#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

- The name of the corporation is EURAM MED-ID SYSTEMS, INC.
- The address of the corporation is 3838 Tamiami Trail North, Suite 416, Naples, Florida
   34103
- The period of its duration is perpetual.
- 4. The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and the State of Florida.
- The corporation shall have authority to issue seventy-five hundred shares, all of one class, one dollar par value.

The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.
