**ARTICLES OF INCORPORATION
OF
C&F RESTAURANT AND CATERING SERVICES, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be C&F RESTAURANT AND CATERING SERVICES, INC.

ARTICLE II: PRINCIPLE OFFICE
