

ARTICLES OF INCORPORATION

ARTICLE ONE

The name of the corporation is Bessie J. Manuel Holding Corporation. The principle office is located at 11450 West Sample Road, Coral Springs, Florida 33065.

ARTICLE TWO

The period of duration is perpetual.

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
