

The undersigned incorporator to these Articles of Incorporation, Sa matural person ATE TALLAHASSEE FLORIDA competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION; PRINCIPAL OFFICE ADDRESS; MAILING ADDRESS

The name of this corporation shall be "Hernández Construction Company". The principal office address and mailing address of the corporation shall be 2779 Willow Bay Terrace, Casselberry, Florida 32707.

ARTICLE II - DURATION

This corporation shall exist perpetually and shall be effective as of October 8, 2001.

ARTICLE III - PURPOSE

The general purposes for which the corporation is organized are:

- 1. To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act; and,

C. Notwithstanding the foregoing, the corporation shall have the right to increase its capital stock either with or without par value, and to provide in the event of such increase the designations, preferences, voting powers or restrictions, or qualification of voting powers, of such additional stock, in an amendment to its Articles of Incorporation.
