
ARTICLE VIII



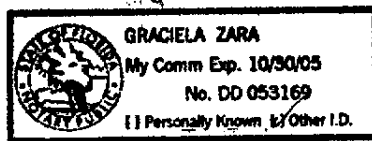
