ARTICLES OF INCORPORATION

OF

GORDON & KENNEY PROPERTIES, INC.



The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be:

GORDON & KENNEY PROPERTIES, INC.

and shall perform all business under the name of:

GORDON & KENNEY PROPERTIES, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III. SHARES

This corporation is authorized to issue 100 shares of common stock with a par value of \$1.00 , which shall be designated "common shares".

ARTICLE IV. PURPOSE

This corporation is organized for the purpose of transacting any and/or all lawful business, including property management.

ARTICLE V. DURATION

This corporation shall commence <u>OCTOBER 3, 2001</u> and shall have perpetual existence.

ARTICLE VI. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE IX. SALE OF SHAREHOLDERS STOCK

If after a period of 30 days, neither the corporation, nor the existing shareholders pick up their option to purchase this stock, then said shareholder may offer his/her stock for sale to the highest bidder.
