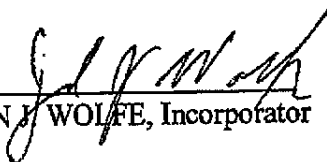

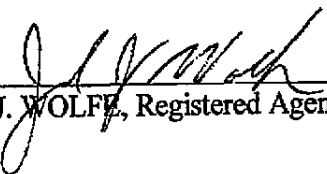
ARTICLE VIII - INDEMNIFICATION.
