A RTICLES OF INCORPORATION OF TAMPA LEGIONAL HOSPITALIST GROUP, P.A.

The undersigned hereby makes, subscribes, acknowledges, and files with the Secretary of State of the State of Florida thes Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE II Name

The name of this corpor tion shall be Tampa Regional Hospitalist Group, P.A.

ARTICLE II Perm of Existence and Fiscal Year

This corporation shall be gin existence on the date of filing of these Articles of Incorporation with the Secretary of State of the State of Florida, and shall have perpetual existence thereafter. This corporation shall have a fiscal year beginning January 1 and ending December 31 of each year.

ARTICLE III Nature of Business

The general nature of the business to be transacted by this corporation, and the objects and purposes thereof, shall be to previde medical services.
