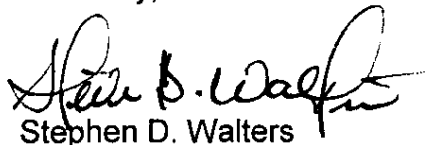
It has just come to my attention that we have not filed our Uniform Business Report for 2003. We never received the original form due to a change in address.
