ARTICLES OF INCORPORATION

OF

A PROFESSIONAL CORPORATION

The undersigned, who practices as a real estate consultant in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

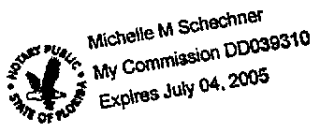
