

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is Howard H. Humburg – Architect, P.A.

ARTICLE II. CORPORATE ADDRESSES

The principal office and mailing address of the corporation is 7219 Altama Rd., Jacksonville, FL 32216 at the time of execution of these Articles.

ARTICLE III. PURPOSE

ARTICLE VII. INCORPORATOR



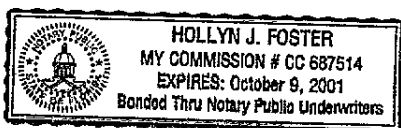


